Remote within the United States, except California. Preference will be given to candidates located in Illinois, Colorado, Pennsylvania, or Texas.

Position Summary

EduDream is seeking a full-time Mixed-Methods Research and Evaluation Associate (REA) to lead and support culturally responsive and equity-centered education research and evaluation projects that elevate the voices and experiences of racially and economically diverse students, families, and communities. The REA will work in a highly collaborative team environment and engage educators, community-based organizations, families, students, and other stakeholders in research projects spanning early childhood through postsecondary and workforce development. The successful candidate will bring at least 5 years of experience in mixed-methods research, evaluation, and project management to advance our mission.

Essential Duties and Responsibilities:

The essential functions include, but are not limited to, the following:

Client Relationships

- Build and maintain client and partner relationships and expectations by identifying needs and delivering evidence-informed solutions.
- Engage clients throughout the research process authentically and transparently.
- Facilitate client and stakeholder meetings, webinars, and workshops
- Strengthen client and partner capacity to use data and evidence to inform policies, practices, and/or strategies that advance educational equity.

Research Design and Implementation

- Lead and execute research and evaluation projects using culturally responsive and equity-focused approaches and mixed methods, from planning and design to implementation. This includes:
 - Creating and refining evaluation plans, logic models, and theories of change
 - Developing and clarifying research, evaluation, and/or learning questions
 - Overseeing data collection, ensuring data validity, quality, and reliability
 - Developing data collection and analyses plans
 - Designing and implementing qualitative and quantitative data collection tools (e.g., surveys, interview or focus group protocols, observation forms, etc.)



- Leading qualitative and quantitative data collection and analysis (e.g., data cleaning, coding, and analysis)
- Interpreting and synthesizing quantitative and qualitative data to identify clear takeaways and data insights.
- Conceptualize analytical frameworks for document reviews, literature reviews, and landscape scans.
- Lead the framing and writing of research and evaluation plans, reports, syntheses of findings, and summaries of key takeaways.
- Develop engaging and impactful high-visibility presentations for technical and non-technical audiences, including clients, stakeholders, and communities at large.
- Ensure deliverables align with culturally responsive and equitable evaluation (CREE) principles, meet the client's expectations, and adhere to EduDream's internal quality assurance processes.

Project Management

- Develop, monitor, maintain, and adjust project work plans to ensure timeliness of completion.
- Identify potential project risks and develop mitigation strategies.
- Monitor and manage project resources effectively to ensure hours are allocated properly; alert leadership to possible issues.

Experience beyond academic studies and academia required, preferably in or with nonprofits, philanthropy, higher education, or the public sector.
- At least 3 years of demonstrated experience leading client and partner relationships, beyond experience in academic studies and academia.
- Demonstrated application of quantitative and qualitative research skills and methods
- Experience synthesizing and communicating research and evaluation findings to a range of audiences
- Strong project management skills and experience managing a portfolio of projects and tasks
- Must be currently eligible to work in the United States without a requirement of visa sponsorship, with no foreseeable changes in eligibility within the next 24 months

Knowledge, Skills, and Abilities

The following knowledge, skills, and abilities are required for this position:

- Experience with data analysis (proficiency in Excel and/or statistical software such as R Studio, STATA, or SPSS), including preparing complex data sets for analysis (cleaning, merging, recoding, and data validation)
- Experience applying qualitative analysis frameworks to primary data. Some experience with qualitative data software (e.g., Nvivo) is preferred.
- Experience facilitating stakeholder interviews and focus groups and designing surveys
- Experience identifying and applying appropriate quantitative analysis methods, including descriptive statistics, regression, and correlation analysis, to generate insights. Experience with advanced methods, such as predictive modeling, time series analysis, and hierarchical linear modeling (HLM), is a plus.

Our Work Schedule and Environment

This is a remote, full-time position. Candidates must be located within the United States. Preference will be given to candidates located in Illinois, Colorado, Pennsylvania, or Texas. Candidates in California are not eligible at this time.

The REA will be expected to work Monday-Friday within a set schedule, which is typically 9-5pm CST. For some projects, our team visits clients in-person at their organizations.

Compensation

The salary range for a full-time salaried position is \$70,000-\$80,000, depending on experience and qualifications. Opportunities are available for annual merit-based performance increases and annual incentives. Benefits include:

- PTO: 2.5 weeks vacation (increases to 4 weeks beginning the 3rd year of employment),
 11 paid holidays, and 5 paid sick days per year
- Employer-sponsored health, dental, and vision insurance. All health benefits are effective on the first of the month following the hire date.
- Matching employer contributions to an individual retirement account after 90 days of employment.
- Professional development funding
- A 32.5-hour workweek.
